

2026 Scholarship Qualifications

\$1,500 Livingston Family – H. J. King Memorial Scholarship (*1 awarded*)

\$500 Wyoming Farm Bureau Federation Scholarships (*5 awarded*)

Qualifications

1. Applicant age.
 - If applicant is 21 years or younger at the time of applying, they must be a current member or have an immediate family member (parent or guardian) who is a current member of a Wyoming County Farm Bureau Federation.
 - A Mountain West Farm Bureau Mutual Insurance Company insurance policy DOES NOT QUALIFY as having a Wyoming County Farm Bureau Federation membership or as involvement in the Wyoming Farm Bureau Federation (WyFB).
 - If applicant is 22 years or older at the time of applying, they must be a current member of a Wyoming County Farm Bureau Federation.
2. Secondary education. Applicant must be:
 - A Wyoming high school graduate, or
 - A Spring 2026 Wyoming high school graduating senior, or
 - A Wyoming resident who, at the time of application submission, has successfully completed or will successfully complete their final semester of academic curriculum with a home school, charter school, virtual school, or GED program.
3. Post-secondary education. Proof of enrollment status is required prior to scholarship disbursement. At the time the scholarship is granted, the applicant must be enrolled to attend:
 - The University of Wyoming
 - A Wyoming junior college
 - A Wyoming trade school
 - An accredited virtual college or university as long as the student is a Wyoming resident and lives in Wyoming.
4. The applicant must be entering a postsecondary education program for the first time after completing their secondary education program. A returning college freshman, sophomore, junior, senior, graduate student, or student returning to a trade school program or seeking additional training is not eligible for the Livingston Family – H. J. King Memorial Scholarship or a WyFB Federation Scholarship (but may qualify to apply for a WyFB Federation Continuing Education Scholarship).

5. Scholarship selection will be on a deserving basis; however, the recipient must have at least a 3.0 scholastic grade point average based upon a 4.0 scale.
6. Application must be complete and accompanied by all required documentation as noted on the application form.
7. **Application must be hard copy and postmarked by or received on or before March 1 of the application year.** Mail application to: Wyoming Farm Bureau Federation, PO Box 1348, Laramie, WY 82073.
8. The recipient of the Livingston Family – H.J. King Memorial Scholarship may also be awarded a WyFB Federation scholarship at the discretion of the Scholarship Committee.
9. No one will be disqualified because of sex, race, color, creed, or religious beliefs.

- ✓ A complete and legible application.
- ✓ A current photograph on the cover page of the application.
- ✓ A transcript or grade report of your two most recent semester grades.
- ✓ At least three (3) current letters of recommendation (6 months or newer) describing your educational ability, character, and financial need. Recommendations may come from any of the following (but only one recommendation from each category):
 - Farm Bureau Federation Leader
 - Farm Bureau Federation Member
 - Farm Bureau Agent
 - School Teacher or School Administrator
 - Community Leader
 - Church Leader
 - Employer

SELECTION PROCESS

- The Scholarship Committee begins the selection process after the application deadline. Applicants are notified as soon as possible thereafter.
- The presentation of awards is made by mail from the state office in the form of a check made payable to the scholarship recipient.
- Award checks are issued upon timely receipt of:
 1. **A high-resolution digital photograph via email upon notification of their award for use in official announcements.**
 2. **Proof of enrollment for the fall semester (electronic or hard copy acceptable) no later than September 15 of the application year.**
 3. If the scholarship recipient fails to submit items #1 and #2 above in a timely matter, the scholarship will be awarded to an alternate applicant according to score.
- Scholarship recipients are selected using the following 100-point system:

<u>Possible Score</u>	<u>Category</u>
20 points	Scholastic Record
20 points	Leadership; School Activities/Organizational Involvement; Work Experience
20 points	Farm Bureau Organization Involvement
15 points	Response Question
15 points	References
10 points	Financial Need
